NOTIFICATION

Whereas, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an Institution of higher learning as deemed to be University.

- 2. **And whereas**, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government, vide Notification No.9-9/98-U.3 dated 02.08.2002, on the advice of UGC, had declared S.R.M. Institute of Science & Technology, Chennai comprising S.R.M. Dental College, Chennai, as an Institution deemed to be University, for the purpose of the aforesaid Act.
- 3. **And further whereas,** in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government permitted S.R.M. Institute of Science & Technology, Chennai to bring the following Institutions under its ambit subject to review after three years:
 - i. S.R.M. Engineering College, Kattankulathur, Chennai, Tamil Nadu, vide Notification No.9-8/98-U.3 dated 13th March, 2003;
 - ii. S.R.M. Medical College Hospital and Research Centre, Kattankulathur, Chennai, Tamil Nadu, vide Notification No.9-27/2004-U.3 dated 30th September, 2004;
- iii. S.R.M. College of Pharmacy, Chennai, Tamil Nadu, vide Notification No.9-47/2004-U.3 dated 28th January, 2005;
- iv. S.R.M. College of Nursing, Chennai, Tamil Nadu, vide Notification No.9-47/2004-U.3 dated 28th January, 2005;
- v. S.R.M. College of Physiotherapy, Chennai, Tamil Nadu, vide Notification No.9-47/2004-U.3 dated 28th January, 2005;
- vi. S.R.M. College of Occupational Therapy, Chennai, Tamil Nadu, vide Notification No.9-47/2004-U.3 dated 28th January, 2005; and
- vii. S.R.M. Institute of Management & Technology, Modinagar, Distt. Meerut, Uttar Pradesh, vide Notification No.9-47/2004-U.3 dated 28th January, 2005.
- 4. **And whereas**, the functioning of S.R.M. Institute of Science & Technology, Chennai as well as all its constituent units was reviewed by the UGC. Taking into

consideration the advice of UGC and in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Government, vide Notification No.9-9/1998-U.3 dated 16th October, 2008, accorded approval to the continuation of S.R.M. Institute of Science & Technology, Chennai as a deemed to be University, for a further period of five years i.e. upto 15.10.2013.

- 5. **And whereas,** the functioning of S.R.M. Institute of Science & Technology, Chennai and all its constituent units/institutions was again reviewed by the UGC with the help of Expert Committee in the year 2017. The report of the Expert Committee was considered and approved by the Commission.
- 6. **Now, therefore**, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Government, on the advice of the UGC, do hereby extend the deemed to be University status of S.R.M. Institute of Science & Technology, Chennai from **16.10.2013 to 15.08.2023** with the condition that the Institution shall improve its performance and academic outcomes on the parameters mentioned in the UGC (Institutions Deemed to be Universities) Regulations, 2019.
- 7. The all other conditions mentioned in the earlier Notification(s) of this Ministry as well as the Rules / Regulations of UGC and other Statutory Councils, issued from time to time, shall continue to be adhered by S.R.M. Institute of Science & Technology, Chennai, Tamil Nadu.
